**Welcome to the 2015 Beast of Bladenboro Festival, Downtown Bladenboro, NC.** You are invited to submit an application for our festival to be held on **Saturday, October 31, 2015, from 10:00 am until 10:00 pm.**

***The deadline for Vendor Applications is October 24, 2015!***

Registration & setup will begin on **Saturday, October 31, from 6:30am to 8:30am.** It is requested that all vendors remain open until at least **6:00 pm** the day of the event. Restroom facilities & trash receptacles will be provided. Food vendors are responsible for properly disposing of any & all cooking refuse and for meeting Bladen County Health Department requirements (910-862-6852). Vendors are responsible for supervising their children at all times.

Power requirement: Due to limited availability, power sources will be available only on a "first come-first serve" basis. Applicable fees are listed on the vendor application. Vendors are responsible for extension cords. Whisper quiet generators are required, especially in the main entertainment area of the festival.

**In selecting our vendors, every effort will be made to minimize the duplication of products sold.**

Paraphernalia items identifiable as drug or tobacco product related are prohibited. The sale of pets and exotic pets/animals is prohibited.

All applicants are required to return the following items to the Festival Committee for consideration:

1. Legible completed & signed vendor application
2. Money order, cash or certified check for the entire amount of the registration fee.  
Certified checks will be made payable to "Boost the 'Boro".
3. Detailed list of food/craft items you intend to sell.
4. Size of space needed for your booth or trailer.
5. At least two (2) photos or a brochure of your merchandise/booth or trailer.  
Applications without included photo or brochure will not be considered.

6. If you wish to have your photos returned, please include a self-addressed stamped envelope with your application.
